Bus Terminal at Vyttila is located in 8 Acres of land at Vyttila; Kochi is part of the proposed Vyttila Mobility Hub. The terminal has earmarked an exclusive area for the Food court/restaurant and a Kiosk (Snack Bar) for the convenience of commuters using Vyttila Mobility Hub.

#### 2. Scope of Work

- 1. To furnish with furniture and establish the restaurant/food court and Kiosk
- 2. To run the food court and Kiosk
- 3. To dispose the solid waste and to treat waste water generated in the food court.
- 4. To make timely payments of License Fee and other charges to VMHS
- 5. Adhere to all statutory norms.

## 3. Notice Inviting Tender:

VMHS is inviting tenders from reputed financially sound, resourceful and experienced hoteliers, for Establishing, operation and Maintenance of the restaurant and kiosk in the Bus Terminal at Vyttila with following prequalification criteria. - 3) The average annual turnover of the bidder in the Catering industry during the last three financial years should not be less than Rs.100 lakhs. The bidder should be a profit making concern for the last three years.
